SECTION 4: FIRST AID MEASURES

4.1. Description of first aid measures

General information

In all cases of doubt, or when symptoms persist, seek medical attention. Never give anything by mouth to an unconscious person.

İnhalation

Remove to fresh air, keep the patient warm and at rest. If breathing has stopped administer artificial respiration. Give nothing by mouth. If unconscious, place in the recovery position and seek medical advice. Ingestion

If accidentally swallowed rinse the mouth with plenty of water (only if person is conscious) and obtain immediate medical attention. Keep at rest. Do NOT induce vomiting.

Skin contact

SECTION 7: HANDLING AND STORAGE

7.1. Precautions for safe handling

Prevent the creation of flammable or explosive concentrations of vapour in air and avoid vapour concentrations higher than the occupational exposure limits. Keep away from heat, sparks and open flame. Avoid skin and eye contact. Smoking, eating and drinking should be prohibited in application area. Avoid inhalation of vapour and spray mist. Avoid inhalation of dust.

8.2. Exposure controls

Engineering measures
