BRUSH-ON ANTISLIP COATING FOR TIMBER

Hickson Decor Antislip is a solvent based, medium build, self priming clear coating. It is a clear protective coating for brush application onto unweathered pressure preservative treated decking timbers or exterior wood flooring.

AREAS OF USE

On new (clean and dry) pressure preservative treated timber decking in external situations.

MAIN FEATURES

- Provides a highly water repellent finish
- Reduces the timber's capacity to retain water
- Contains abrasive particles to give a textured, hard wearing surface coating
- Helps provide sure footing and reduce slippery conditions in wet weather
- · limits the nutrients required for the growth of organisms that can cause slippery conditions

CAN SIZES

Hickson Decor Antislip is available in 1.0, 2.5 and 5.0 litre can sizes.

SURFACE PREPARATION

Remove any dirt, dust, oil or grease. Surface must be dry.

New surfaces - no other preparation.

Weathered surfaces – sand down to clean, sound, treated wood (use dust mask if using sanding equipment with no dust collection).

Previously painted or stained surfaces – any old coating must be clean and in sound condition. Lightly sand to 'key' the surface.

Decking systems - apply two coats of Hickson Decor Wood Oil prior to the application of Hickson Decor Antislip coating. This will ensure a professional level of protection.

METHODS OF APPLICATION

One liberal coat. Allow time for absorption along the grain of the timber.

By brush, short haired roller or 'vee' applicator only. On grooved decking care must be taken to ensure that the coating adheres to the ridge of the timber and is not 'lost' in the groove. Roller application is recommended in this situation. Take care not to overapply and leave thick 'pooled' layers of the coating as these may not fully cure and may result in a cloudy appearance after rain. Mix thoroughly before and during use.

MAINTENANCE AND CLEANING

When required, every 1-2 years, depending on the level and nature of the traffic on the flooring. When wear through to the substrate has occurred, it is only necessary to touch up the worn area. Always remove leaves and decaying vegetation from the surface decking as soon as possible in order to retain the benefits of the Hickson Decor Antislip surface.

Clean brushes and spillages with white spirit. Remove as much paint as possible from brush before washing. Some Local Authorities have special facilities for disposing of waste coatings. Do no empty paint into drains and watercourse. Do no empty paint into drains and watercourse. Do not use white spirit on skin. A proprietary hand cleaner should be used.

Protect from extremes of temperature during storage and application.

HAZARDS IDENTIFICATION

The product is classified as flammable, irritant and dangerous for the environment according to the CHIP Regulations. Flammable.

If accidentally swallowed obtain immediate medical attention. Keep at rest. Do NOT induce vomiting.

FIRE FIGHTING MEASURES

Extinguishing Media:

RECOMMENDED: Alcohol resistant foam, CO₂ powder, water spray/mist

NOT TO BE USED: Water jet

Recommendations:

Fire will produce dense black smoke containing hazardous products of combustion (see Section 10). Exposure to decomposition products may be a hazard to health. Appropriate self-contained breathing apparatus may be required. Cool closed containers exposed to fire with water spray. Do not allow run-off from fire fighting to enter drains or watercourses.

6 ACCIDENTAL RELEASE MEASURES

Exclude sources of ignition and ventilate the area. Exclude non-essential personnel. Avoid breathing vapours. Refer to protective measures listed in Sections 7 and 8. Contain and collect spillages with non-combustible absorbent materials, e.g. sand, earth, vermiculite, diatomaceous earth and place in a suitable container for disposal in accordance with the waste regulations (see Section 13). Do not allow to enter drains or watercourses. Clean preferably with a detergent and avoid the use of solvents.

If the product enters drains or sewers the local Water Company should be contacted immediately; in case of contamination of streams, rivers or lakes, the relevant environment agency.

HANDLING AND STORAGE

Handling:

Vapours are heavier than air and may spread along floors. They may form explosive mixtures with air. Prevent the creation of flammable or explosive concentrations of vapour in air and avoid vapour concentrations higher than the workplace exposure limits.

Additionally, the product should only be used in areas which all naked lights and other sources of ignition have been excluded. Electrical equipment should be protected to the appropriate standard. Keep the container tightly closed. Exclude sources of heat, sparks and open flame. Non-sparking tools should be used.

Avoid skin and eye contact. Avoid inhalation of vapour and spray mist.

Smoking, eating and drinking should be prohibited in areas of storage and use.

For Occupational Exposure Controls, see Section 8.

Never use pressure to empty, the container is not a pressure vessel.

Always keep in containers made of the same material as the supply container.

Good housekeeping standards including the regular safe removal of waste materials and regular maintenance of spray booth filters will minimise risks of spontaneous combustion and other fire hazards.

The Manual Handling Operations Regulations may apply to the handling of containers of the product. Refer to the guide weight indicated on the container when carrying out assessments.

Storage:

The storage and use of this product is subject to the requirements of the Dangerous Substances and Explosive Atmosphere Regulations 2002 (DSEAR). The requirements are given in the HSE Approved Code of Practice and Guidance, Storage of Dangerous Substances. Up to 250 litres of such highly flammable liquids may be kept in a workroom provided they are kept in a fireproof cupboard or bin. Larger quantities must be kept in a separate storeroom conforming to the structural requirements of the regulations. Further guidance is contained in the HSE guidance note Storage of Flammable Liquids in Containers.

Observe the label precautions. Store between 5 and 25°C in a dry, well-ventilated place away from sources of heat, ignition and direct sunlight. No smoking. Prevent unauthorised access. Containers that are opened should be properly resealed and kept upright to prevent leakage. The principles contained in the HSE guidance note Chemical Warehousing: The Storage of packaged Dangerous Substances should be observed when storing this product. Store separately from oxidising agents and strongly alkaline and strongly acidic materials.

Exposure Controls:

Provide adequate ventilation. Where reasonably practicable this should be achieved by the use of local exhaust ventilation and good general extraction. If these are not sufficient to maintain concentrations of particulates and/or solvent vapours below the relevant workplace exposure limits, suitable respiratory protective equipment should be worn (see Personal Protection below).

Personal Protection:

10 STABILITY AND REACTIVITY

Stable under the recommended storage and handling conditions (see Section 7). In a fire, hazardous decomposition products such as smoke, carbon monoxide and carbon dioxide and oxides of nitrogen may be produced.

Keep away from oxidising agents and strongly alkaline and strongly acidic materials to prevent the possibility of exothermic reaction. Keep dirty wipers in an enclosed container.

11 TOXICOLOGICAL INFORMATION

There is no data available on the product itself. The product has been assessed following the conventional method of CHIP and is classified for toxicological hazards accordingly. This takes into account, where known, delayed and immediate effects and also chronic effects of components from short-term and long-term exposure by oral, inhalation and dermal routes of exposure and eye contact. See Sections 3 and 15 for details of the resulting hazard classification.

Exposure to organic solvent vapours in excess of the stated occupational exposure limit may result in adverse health effects, such as irritation of the mucous membrane and the respiratory system and adverse effects on the kidney, liver and central nervous systems. Symptoms and signs include headache, dizziness, fatigue, muscular weakness, drowsiness and in extreme cases, loss of consciousness.
